Corporations, associations and individuals that support the objectives and activities of Farm & Food Care Ontario may apply for membership at the following levels:

Platinum Membership – Support of \$30,000 or greater

Platinum members may appoint an individual to attend and vote at any meeting, hold any office and sit on either or both of the Animal Care Advisory Council and the Environment Advisory Council. Platinum Members receive priority consideration for new committees and strategy sessions, and receive three (3) complimentary registrations to the FFCO Annual General Meeting.

Top priority access to an unlimited number of complimentary Speaker Service sessions, and top priority for customized Training Workshops; all other services and publications are also available.

Gold Membership – Support of \$ 5,000 or greater

Gold members may appoint an individual to attend and vote at any meeting, hold any office and sit on the Animal Care Advisory Council and the Environment Advisory Council. Gold members receive priority invitation to new committees and strategy sessions, and two (2) complimentary registrations to the FFCO Annual General Meeting.

Two (2) complimentary Speaking Service sessions, customized rates for standard Training Workshops; all other services and publications are also available.

Silver Membership – Support of \$1,500 or greater

Silver members may appoint an individual to attend and vote at any meeting, hold any office and sit on the Animal Care Advisory Council and the Environment Advisory Council. Silver members receive priority invitation to new committees and strategy sessions.

One (1) complimentary Speaking Service session, reduced rates for standard Training Workshops; all other services and publications are also available.

Affiliate Membership – Support of \$1,500 or greater

This category is designed to include organizations outside of Ontario that are supportive of Farm & Food Care Ontario's objectives and would like access to services and benefits at reduced rates.

Supporter Membership – Support of \$250 or greater

Supporter members may be individuals, organizations or companies who support the mission of our organization. All services are available at reduced rates.
