Election of FFCO's executive also took place today. Bonnie den Haan has been re-elected chair of the board for a third one-year term. Crispin Colvin, nominated by the Ontario Federation of Agriculture, will serve as first vice chair, and Janelle Cardiff, nominated by Egg Farmers of Ontario will serve as second vice chair. John Taylor, nominated by the Ontario Mutual Insurance Association, has been re-elected as treasurer.

Chair Bonnie den Haan said, "Farm & Food Care Ontario's efforts to promote the work of farmers and food processors are so vital. As chair over the last two years, I have been overwhelmed by the positive energy in the agricultural industry; especially when we work together, we can achieve amazing results. I am very much looking forward to expanding the reach of our initiatives this year."

Vice Chair Crispin Colvin added, "I'm extremely proud of the work that Farm & Food Care Ontario does to bring awareness, appreciation and information about agriculture to our neighbors across Ontario. It is going to be an exciting year for FFCO, and I am looking forward to moving ahead with all our projects."

At the organization's online annual business meeting, voting members approved changes to the by-laws as they relate to the two existing member councils - Farm Animal Care and Farm Environmental Councils. These councils will cease to exist.

Replacing them will be a new Member Forum, with membership from FFCO's Platinum, Gold and Silver members. This forum, like the councils before, will meet three or four times annually and will feature topics and speakers across all areas of work – animal care, environment and public trust. Chairs for the new forum will be selected at its first meeting in June.
